6 A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF
7 THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO
8 AD VALOREM TAXES; ESTABLISHING THE PROPOSED
9 MAXIMUM MILLAGE RATE AND SETTING THE DATES,
10 TIMES AND LOCATION FOR THE FIRST AND SECOND
11 BUDGET HEARINGS FOR FY 08-09; FURTHER DIRECTING
12 THE VILLAGE CLERK TO FILE SAID RESOLUTION WITH
13 THE MIAMI-DADE COUNTY PROPERTY APPRAISER; AND
14 PROVIDING FOR AN EFFECTIVE DATE.

17 WHEREAS, the Village has received the Certification of Taxable Value from the
18 Miami-Dade County Property Appraiser; and,

20 WHEREAS, the Village is required under State Statutes to establish and furnish to the
21 Property Appraiser the proposed maximum millage rate and the dates, times and location(s) at
22 which public hearings will be held to consider the FY 08-09 millage rate and budget; and,

24 NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE
25 COUNCIL OF THE VILLAGE OF PLAMETTO BAY, FLORIDA, AS FOLLOWS:

27 Section 1. The proposed maximum millage rate for the Village of Palmetto Bay for
28 FY 08-09 is established at 2.5582 mills, which is \$2.5582 for each \$1,000.00 of assessed property
29 within the Village of Palmetto Bay.

31 Section 2. The rollback millage rate is 2.4476 mills.

33 Section 3. The proposed date and place of the first and second public hearings are
34 scheduled as follows:


44 Section 4. The Village Clerk is directed to file the original certification of Taxable
