**RESOLUTION NO. 08-79**

**A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO CONTRACTS; AUTHORIZING THE VILLAGE MANAGER TO "PIGGY BACK" ONTO THE EXISTING AGREEMENT BETWEEN THE VILLAGE OF PINECREST AND ENVIROWASTE SERVICES GROUP, INC. FOR ADDITIONAL STORM DRAIN CLEANING SERVICES WITHIN THE VILLAGE OF PALMETTO BAY; AUTHORIZING THE VILLAGE MANAGER TO ISSUE A PURCHASE ORDER IN AN AMOUNT NOT TO EXCEED \$25,000.00; AND PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, the Village of Palmetto Bay requires a contractor to continue providing storm drain cleaning within the boundaries of the Village; and,

WHEREAS, the Village of Pinecrest has contracted with Envirowaste Services Group, Inc. for the jet cleaning of catch basins, French drains and connecting pipes pursuant to their response to a request for proposals; and,

WHEREAS, pursuant to the Village's purchasing procedures, the Village may enter into contracts for services with contractors without following competitive bidding procedures when another public agency has already followed proper formal bid procedures; and,

WHEREAS, the Village would like to "piggyback" the contract between Envirowaste Services Group, Inc. and the Village of Pinecrest; and,

WHEREAS, Envirowaste Services Group, Inc. has agreed to provide the necessary services and resources to the Village utilizing the same pricing, terms and conditions as set forth in Agreement with the Village of Pinecrest.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:**

Section 1: The Village Manager is authorized to "piggy back" on the Village of Pinecrest bid no. 5435-3/11 and 6590-3/08-2 for various drain cleaning services contract with Envirowaste Services Group, Inc. and is authorized to execute a purchase order in an amount not to exceed \$25,000 for storm drain cleaning to the approved vendor under the terms and conditions set forth in the agreement between the Village of Pinecrest and Envirowaste Services Group, Inc.

Section 2: This resolution shall take effect immediately upon approval.
