

We hereby submit specifications and estimates for:

- 1) Revelation Sound, Inc. (RSI) will deliver and install equipment listed in Quotation #081215-01M and 17641 Community Room Audio Diagram dated 12-26-2008. This proposal and these documents specify and define this agreement in it's entirety.
- 2) RSI will install all the equipment as listed in the quote. This includes an Rane MLM manual audio mixing system. The audio system equipment will be in the closet area located to the North of the Community Room.. The loudspeakers will be located in the ceiling in as even a pattern as is possible.
- 3) RSI will pull all the wires as per the Sound System Block Diagram. All wiring is specified as conduit run. RSI will specify the type and placement of all Sound System conduit to your Architect for installation by your Electrical Contractor conduit costs are NOT included.
- 4) The City must provide One (1) 120VAC 20A circuit & receptacles for the sound equipment at the equipment rack location. The circuit purposes of the audio system. Failure to provide these dedicated, isolated circuits may result in ground loop humming, buzzing, or other issues of which RSI could not anticipate and thus will not be held responsible for the problems.
- 5) RSI will warranty the installation work against installation related defects for a period of 1 year. This pertains specifically to rack wiring, speaker mounting hardware, plate work and connectors that are installed by RSI. Work done by others on this contracted system during the one (1) year time period will not be covered under this warranty and may result in additional charges. Labor to correct any system problems or issues having to do with the electronics will be covered for a period of ninety (90) days upon completion of System Installation / Customer Sign-Off. Work done by others on this contracted system during the ninety (90) day time period will not be covered under this warranty and may result in additional charges. Manufacturer's equipment Warranties vary, depending on the Manufacturer and the product. Manufacturer's Warranties may not cover all equipment failures, such as "Acts of God." After the RSI warranty period of 90 days, additional charges, such as Shipping and Handling, as well as the labor involved for trouble shooting / diagnostics / removal / installation, will apply to correct any system problems or issues pertaining to the electronics.
- 6) Revelation Sound, Inc. will pull all necessary permits and attend required inspections required by the municipality governing this jobsite. All costs associated with permitting (drawings, manpower, permit fees, etc) are NOT included in this quotation and will be invoiced separately to the customer. This includes travel time to the project site for inspections and/or to municipal offices in association with any
