**A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, REGARDING PARKS AND RECREATION; AUTHORIZING THE USE OF CORAL REEF PARK AT NO COST ON DECEMBER 8, 2019 TO DEPARTMENT OF THE ARMY B CO, 377<sup>TH</sup> MILITARY INTELLIGENCE BATTALION FOR THE PURPOSE OF CONDUCTING A FAMILY READINESS GROUP SUPPORT EVENT; AND PROVIDING AN EFFECTIVE DATE.
