A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO REQUEST FOR PROPOSAL # 1819-11-010 EMERGENCY DEBRIS REMOVAL AND DISPOSAL; APPROVING THE SELECTION OF FIVE CONTRACTORS TO PROVIDE EMERGENCY DEBRIS REMOVAL AND DISPOSAL TO THE VILLAGE; AUTHORIZING THE VILLAGE MANAGER TO EXECUTE CONTRACTURAL AGREEMENTS WITH CERES ENVIORNMENTAL, CROWDER GULF, DRC EMERGENCY SERVICES, BERGERON EMERGENCY SERVICES AND SFM SERVICES, INC.; AND PROVIDING FOR AN EFFECTIVE DATE. *(Sponsored by Administration)*

WHEREAS, the Village of Palmetto Bay may experience destruction of property resulting from hurricanes, floods, tornadoes, and other weather-related events as well as other natural disasters; and

WHEREAS, in the event of major disaster, the Village will not have adequate in-house resources to provide assistance and recovery to the community; and

WHEREAS, it is imperative that that the Village has standby agreements with a minimum of five (5) contractors to provide quick response to expedite post-storm recovery clean-up in advance of the need for emergency debris removal services; and

WHEREAS, on March 6, 2019, the Village issued a Request for Proposal (RFP) # 1819-11-010 for Emergency Debris Removal and Disposal for a period of three (3) years, with the option to allow the Village at its sole discretion to renew for an additional two (2) extra years but not to exceed (5) consecutive years.

WHERAS, on April 9th, 2019, the Village received a total of 10 proposals, a selection panel graded and ranked the top 5 contractors to enter into an agreement: Ceres Environmental, Crowder Gulf, DRC
