

RESOLUTION NO. 2019-104

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO PARKS AND RECREATION; APPROVING THE PROPOSED MASTER PLAN COMPONENTS FOR PALMETTO BAY PARK ON AN ITEM BY ITEM BASIS FROM RECOMMENDATIONS LISTED HEREIN; PROVIDING FOR AN EFFECTIVE DATE. (Sponsored by Administration)

WHEREAS, following a series of public meeting and the offering of input by Village of Palmetto Bay citizenry regarding proposed revisions to the existing Palmetto Bay Park Master Plan, a summary identifying recommendations was compiled for subsequent reviews and approvals; and

WHEREAS, pursuant to a comprehensive presentation of the all components and/or items recommended for the newly proposed Palmetto Bay Park Master Plan on April 22, 2019, the Village Council direct the Manager to schedule a final review and consideration for approval, on an item by item basis for finalization of the subject Master Plan.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE OF PALMETTO BAY, FLORIDA, THAT:

Section 1. The following recommendations shall be reviewed and considered for approval for incorporation into the Palmetto Bay Park Master Plan on an independent, item-by-item basis, with those approved formally becoming a part of the 2019 Palmetto Bay Park Master Plan:

- a. Splash Pad
- b. Enhanced Landscaping
- c. Pine Tree Preserve
- d. New Walkways
- e. Sensory Garden
- f. ADA Restroom
- g. Expanded Recreation Building
- h. Labyrinth

- i. Improved Skate Park
- j. New Fence
- k. Expanded Basketball Courts
- l. Storage

Section 2. This Resolution shall take effect immediately upon its adoption.
