

**RESOLUTION NO. 2019-137**

**A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO TRAFFIC CONTROL; INITIATING DISPUTE RESOLUTION PROCEDURES PURSUANT TO FLORIDA STATUTE 164.1052(1) WITH RESPECT TO THE EXISTING DISPUTE AND LITIGATION BETWEEN THE VILLAGE AND MIAMI-DADE COUNTY REGARDING STOP SIGNS AT THE INTERSECTION OF SW 87<sup>TH</sup> AVENUE AND SW 174<sup>TH</sup> STRTEET; AND PROVIDING AN EFFECTIVE DATE. (*Sponsored by Vice Mayor John DuBois*)**

**WHEREAS**, the Village of Palmetto Bay, Florida is in a dispute and litigation with Miami-Dade County, Florida, regarding stop signs at the intersection of SW 87<sup>th</sup> Avenue and SW 174<sup>th</sup> Street within the Village; and

**WHEREAS**, Florida Statute 164.1052(1) requires that litigation and disputes between local government entities proceed through a specified dispute resolution process; and

**WHEREAS**, the required dispute resolution process is initiated by a Resolution of the governing body of the aggrieved local government.

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE OF PALMETTO BAY, FLORIDA, THAT:**

**Section 1.** The Village Council hereby requests and initiates the required dispute resolution process pursuant to Florida Statute 164.1052(1) with respect to the dispute and litigation between the Village of Palmetto Bay and Miami-Dade County regarding stop signs at the intersection of SW 87<sup>th</sup> Avenue and SW 174<sup>th</sup> Street within the Village.

**Section 2.** This Resolution shall take effect immediately upon its adoption.
