

RESOLUTION NO. 2019-144

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, REGARDING PARKS AND RECREATION; AUTHORIZING THE USE OF PALMETTO BAY PARK AT NO COST ON DECEMBER 3, 2019 TO WE COACH FOUNDATION, INC. FOR THE PURPOSE OF CONDUCTING A FUNDRAISING KICKBALL TOURNAMENT; AND PROVIDING AN EFFECTIVE DATE. (Sponsored by Administration)

WHEREAS, We Coach Foundation Inc. was founded as a vehicle to share their motivation, dedication, and willingness to help special needs families on a quest for providing a better, more wholesome life for their children; and

WHEREAS, the mission of the organization is to foster skills through family and individual training, support, and community involvement; and

WHEREAS, We Coach Foundation invites the community into the collective mission to create safe supporting environments for individuals with disabilities to enjoy interest-based activities in South Florida; and

WHEREAS, We Coach Foundation would like to host an Interscholastic Kickball Tournament and recreational activities at Palmetto Bay Park on Tuesday, December 3, 2019 from 10am to 1pm; and is requesting a waiver of all fees in utilization of the ballfields and associated amenities.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE OF PALMETTO BAY, FLORIDA, THAT:

Section 1. We Coach Foundation Inc. is hereby authorized to use Palmetto Bay Park on December 3, 2019, for the purpose of conducting a fundraising kickball tournament, including scheduled games and associated activities.

Section 2. Any and all established user fees are hereby waived, and the We Coach Foundation Inc. shall have use of the needed park

amenities on December 3, 2019 at no costs; with the proviso that the recipient comply with all applicable rules, regulations and ordinances.

Section 3. This resolution shall take effect immediately upon its adoption.
