

**RESOLUTION NO. 2019-157**

**A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, REGARDING PARKS AND RECREATION; AUTHORIZING THE USE OF PALMETTO BAY PARK AT NO COST ON JANUARY 26, 2020 TO THE BROTHERS PROJECT, INC. FOR THE PURPOSE OF CONDUCTING A FUNDRAISING MUSIC AND FOOD FESTIVAL; AND PROVIDING AN EFFECTIVE DATE. (Sponsored by Administration)**

**WHEREAS**, The Brothers Project, Inc. was established as a non-profit organization to raise money that would then be distributed to other non-profit organizations (The Andrew Parker Scholarship, GIVE-Growth International Volunteer Excursions and Guy Harvey Ocean Foundation); and

**WHEREAS**, these organizations were chosen to reflect the passion of Wayne and Colette Powell's three sons (Andrew Parker, Jackson Powell, and Jonathan Parker); and

**WHEREAS**, The Brothers Project, Inc. was born from their memory and in a way to contribute to causes they would have been proud to have been associated with.

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE OF PALMETTO BAY, FLORIDA, THAT:**

**Section 1.** The Brothers Project, Inc. is hereby authorized to use Palmetto Bay Park on January 26, 2020, for the purpose of conducting a fundraising Music and Food Festival, including all associated activities.

**Section 2.** Any and all established user fees are hereby waived, and the Brothers Project, Inc. shall have use of the needed park amenities on January 26, 2020 at no cost; with the proviso that the recipient comply with all applicable rules, regulations and ordinances.

**Section 3.** This Resolution shall take effect immediately upon its adoption.
