

RESOLUTION NO. 2019-112

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO THE YOUTH COMMUNITY INVOLVEMENT BOARD (YCIB); APPOINTING MEMBERS TO THE YOUTH COMMUNITY INVOLVEMENT BOARD; AND PROVIDING FOR AN EFFECTIVE DATE. (Sponsored by Village Clerk Missy Arocha)

WHEREAS, the Village Council of the Village of Palmetto Bay previously amended the membership initial appointments of the Youth Community Involvement Board (YCIB) via Resolution No. 2017-05; and

WHEREAS, Resolution No. 2017-05 directs each member of the Village Council to appoint three (3) students to serve on the YCIB, including the Mayor and Vice Mayor and each Charter Officer to appoint two (2) members;

WHEREAS, the YCIB shall consist of school students who reside within, are home schooled, or who attend public or private schools within the municipal limits of the Village of Palmetto Bay; and

WHEREAS, there are several students that are desirous of serving on the Village’s YCIB that reside in the Village of Palmetto Bay and have expressed a huge interest in fostering a greater involvement of youth and teens in municipal government and community service.
