

**RESOLUTION NO. 2019-125**

**A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, REGARDING PARKS AND RECREATION; AUTHORIZING THE USE OF CORAL REEF PARK AT NO COST ON NOVEMBER 17, 2019 TO MIGGY’S GIFT INC FOR THE PURPOSE OF CONDUCTING A MELANOMA WALK-A-MILE; AND PROVIDING AN EFFECTIVE DATE. (Sponsored by Administration)**

**WHEREAS**, Miggy’s Gift Inc. is committed to create awareness & educate about the importance of prevention and early detection of Melanoma; and

**WHEREAS**, money will be raised through the sale of bracelets that contain a detecting bead with all proceeds donated to Melanoma Research; and

**WHEREAS**, Miggy’s Gift is requesting to a waiver of fees to utilize Coral Reef Park (Gazebo Area on east side of park and associated amenities) for a one-mile fun walk on November 17, 2019 from 8:30am to 12 noon.

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE OF PALMETTO BAY, FLORIDA, THAT:**

**Section 1.** Miggy’s Gift is hereby authorized to use Coral Reef Park on November 17, 2019, for the purpose of conducting a fundraising Melanoma Walk-A-Mile.

**Section 2.** User fees are hereby waived, and Miggy’s Gift Inc. shall have use of the needed park amenities on November 17, 2019 at no costs; with the proviso that the recipient comply with all applicable rules, regulations and ordinances.

**Section 3.** This Resolution shall take effect immediately upon its adoption.
