On Friday 2/12/21 I telephoned a report of a Palmetto Bay Code violation to the Code Compliance telephone number.

I followed that call up with a direct report to Inspector Allen White's number.

Today, 2/16/21 the Personal Expression sign in excess of 620 sq in at **7475 SW 173rd St.** is still in place.

This is a clear violation of Palmetto Bay Code 30-90.10 (a) (8), or at least Inspector White's flawed interpretation thereof.

I am requesting that you **provide a copy of the "Palmetto Bay Courtesy Warning Notice"** which imposes a "daily fine of \$250.00" which was issued to the property owners by Inspector White (or other).

I know that uniform enforcement (*vs. selective*) enforcement of Palmetto Bay Code is as important to your office as it is to the Residents.
