

RESOLUTION NO. 2022-03

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, APPROVING THE ISSUANCE OF A LETTER TO THE MIAMI-DADE COUNTY BOARD OF COUNTY COMMISSIONERS EXPRESSING THE COUNCIL’S OBJECTION TO THE COUNTY’S DECISION TO CONSTRUCT THE SW 87TH AVENUE BRIDGE FROM SW 164TH STREET TO SW 163RD TERRACE OVER THE CUTLER DRAIN CANAL C-100; AND PROVIDING AN EFFECTIVE DATE. (*Sponsored by Councilmember Marsha Matson*)

WHEREAS, the Village Council has repeatedly expressed its opposition to the construction of a bridge along SW 87th Avenue from SW 164th Street to 163rd Terrace over the cutler drain canal C-100; and

WHEREAS, the Village is still engaged in conflict resolution with both Miami-Dade County and the County’s Transportation Planning Organization; and

WHEREAS, on November 29, 2021, the Village Council adopted Resolution 2021-109 attached as Exhibit “A” approving the issuance of a letter to the Mayor of Miami-Dade County expressing the Council’s objection to the county’s decision to construct the bridge along SW 87th Avenue; and

WHEREAS, before the conclusion of the conflict resolution process scheduled to occur on January 20, 2022, the Village Council wishes to once again express its opposition and has authorized a letter to be sent to the Board of Commissioners of Miami-Dade County requesting the County to reverse its determination to construct the bridge.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:

Section 1. That the above recitals are incorporated as if set forth in full.
