A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATED TO VILLAGE-WIDE TRAFFIC CALMING IMPROVEMENTS: AMENDING RESOLUTION NUMBER 2022-10 WHICH LISTED BOTH PROPOSED TEMPORARY AND PERMANENT SPEED TABLES BY ADDING SPEED TABLES TO THOSE SHOWN BELOW; AND PROVIDING AN EFFECTIVE DATE. *(Sponsored by Mayor Karyn Cunningham)*

WHEREAS, speeding has become an increasingly alarming issue for residents and the Village of Palmetto Bay continues to be committed to safety and livability of its residential neighborhoods; and

WHEREAS, the installation of speed tables will immediately discourage speeding of vehicles during peak hours, where installed; and

WHEREAS, based on the Interlocal Agreement with Miami-Dade County “Traffic Calming Devices may be installed only after sealed and signed design plans have been reviewed and received written approval by the Village, through its Village Manager or his/her designee”; and

WHEREAS, the Village wishes to amend the temporary speed table listed below.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE OF PALMETTO BAY, FLORIDA, THAT:
