A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO COMMUNITY DEVELOPMENT AND PLANNING AND ZONING; AUTHORIZING THE CORRADINO GROUP, INC., TO PROVIDE A FLOODPLAIN MANAGEMENT PLAN (FMP) FOR THE COMMUNITY RATING SYSTEM (CRS) SERVICES TO THE VILLAGE IN THE AMOUNT OF \$45,000 FOR ONE YEAR; FURTHER AUTHORIZING THE VILLAGE MANAGER TO APPROVE A CONTRACT FOR THESE SERVICES FOR THE STATED AMOUNT; AND PROVIDING FOR AN EFFECTIVE DATE. (Sponsored by Administration)

WHEREAS, the Village of Palmetto Bay is currently participating in the National Flood Insurance Program (NFIP) and became eligible and applied for the Federal Emergency Management Agency’s (FEMA) Community Rating System (CRS) in 2017; and

WHEREAS, the Village’s current voluntary participation in the NFIP CRS provides residents of Palmetto Bay with a discount of ten percent on a standard NFIP flood insurance policy in the Special Flood Hazard Area (SFHA); and

WHEREAS, the Village recognizes the need to improve to well-being of its residents through proactive flooding protocols; and

WHEREAS, the Village of Palmetto Bay desires to continue in its pursuit to lower its rank within the CRS to a 5 or better; and

WHEREAS, the Corradino Group, Inc. will work alongside Wood Environment & Infrastructure Solutions, Inc. to assist the Village with lowering the CRS classification of 5 or better using this FMP that could help achieve a higher discount for residents of Palmetto Bay; and

WHEREAS, this FMP will allow the Village to control its own mitigation/resilient strategies and projects specific for the Village and the FMP will focus more detail specifically on the Village’s flood problems; and

WHEREAS, the Village Manager seeks approval from Council to execute contract.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE OF PALMETTO BAY, FLORIDA, THAT:

Section 1. The following firm is selected to Consulting Services for the Village of Palmetto Bay: The Corradino Group, Inc.

Section 2. The Village Manager is authorized to provide Consulting Services with the Corradino Group, Inc., for Community Rating System (CRS) Consulting Services to improve the quality of life within the Village of Palmetto Bay.

Section 3: The Resolution shall take effect immediately upon approval.
