A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO SPECIAL EVENTS; APPROVING THE ANNUAL “PALMETTO BAY INDEPENDENCE DAY CELEBRATION” ON JULY 4TH, 2022; AUTHORIZING THE VILLAGE MANAGER TO ALLOCATE AND EXPEND UP TO \$55,000.00 NET FUNDING FOR EXPENSES RELATED TO THE ANNUAL EVENT; AND PROVIDING AN EFFECTIVE DATE. *(Sponsored by Administration)*

WHEREAS, July 4th or Independence Day, represents one of the most important dates in our nation’s history, that is proudly celebrated in small and large cities throughout the United States; and

WHEREAS, in recognition of this important occasion, the Village of Palmetto Bay has established the annual Palmetto Bay Independence Day Celebration and fireworks display; and

WHEREAS, in 2019 the event hosted an estimated 8,000 event goers and nicely complemented the existing special events programming in Palmetto Bay; and

WHEREAS, Palmetto Bay residents have been very supportive of community events and have expressed an interest in having more opportunities to share with their neighbors and fellow residents, and the Palmetto Bay Independence Day Celebration serves that purpose; and

WHEREAS, this year’s event will also recognize the Village’s 20-year Anniversary to include a cornucopia of activities for all ages, culminating in a spectacular firework display; and,

WHEREAS, approval is requested from the Village Council to proceed with the event planning and to allocate a funding amount not to exceed \$55,000 net funding to cover associated costs.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:

1 **Section 1.** The Village Manager is authorized to proceed with
2 the planning of the annual “Palmetto Bay Independence Day
3 Celebration” scheduled for July 4th, 2022.

5 **Section 2.** The Village Manager is authorized to allocate an
6 amount not to exceed \$55,000.00 net funding to cover the costs
7 associated with the event.

9 **Section 3.** This Resolution shall become effective immediately.
