A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, REQUESTING THAT MIAMI-DADE COUNTY ANALYZE ACCESS MANAGEMENT TO THE MEDIAN AT THE ENTRANCE OF TUSCANY VILLAS LOCATED AT THE INTERSECTION OF SW 136TH STREET AND SW 85TH AVENUE; DIRECTING THE VILLAGE MANAGER TO TRANSMIT THIS RESOLUTION TO MIAMI-DADE COUNTY DEPARTMENT OF TRANSPORTATION AND PUBLIC WORKS AND PROVIDE SUPPORT WITH DESIGN SOLUTIONS; AND PROVIDING FOR AN EFFECTIVE DATE. *(Sponsored by Mayor Cunningham and Co-Sponsored by Councilmember Fiore)*

WHEREAS, the entrance to Tuscany Villas located at 136th Street and SW 85th Avenue is not currently accessible via the west bound lane on 85th Avenue; and

WHEREAS, in an effort to address the concerns of the residents who live within this community in regard to access management and safety, the Village is requesting that Miami-Dade County assess the need for a median opening and make a determination as to whether a west bound left turn is warranted; and

WHEREAS, the Village Manager shall transmit this Council request to Miami-Dade County Department of Transportation and Public Works for a formal response from the County; and

WHEREAS, the Village Manager will provide support with design solutions regarding this request.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE OF PALMETTO BAY, FLORIDA, THAT:

Section 1. The Village Council hereby requests that the Miami-Dade County Department of Transportation and Public Works review the intersection at SW 136th Street and SW 85th and make a determination as whether the need for a west bound left- hand turn on 85th Avenue is warranted.

1 **Section 2.** The Village Manager is authorized to spend up to
2 and including fifty thousand dollars (\$50,000) to conduct a traffic and
3 engineering study.

5 **Section 3.** That the Village Manager is hereby directed to
6 transmit this resolution to the Miami-Dade County Department of
7 Transportation and Public Works.

9 **Section 4.** This Resolution shall become effective upon
10 adoption.
