**A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AUTHORIZING SHUTTLE BUS IN-KIND SERVICES FROM THE DEPARTMENT OF PUBLIC SERVICES FOR THE FIFTH GRADE CLASS OF HOWARD DRIVE ELEMENTARY SCHOOL ON JUNE 3, 2022, IN AN AMOUNT NOT TO EXCEED \$150.00; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, Howard Drive Elementary School has requested in-kind services for the use of two (2) Palmetto Bay Buses from the Village of Palmetto Bay Department of Public Services, Division of Transit Operations for their June 3, 2022, Fifth Grade End of Year Celebration; and

**WHEREAS**, Howard Drive Elementary School is looking for the Village to partnership with in-kind support in helping to provide transportation to and from the Howard Drive Elementary School and Thalatta Estate via the I-buses; and

**WHEREAS**, due to the number of kids attending the celebration, the use of two (2) Palmetto Bay Buses with drivers to shuttle students from Howard Drive Elementary School to Thalatta Estate are being requested; and

**WHEREAS**, the buses will be needed from 9:00am to 10:00am to transport student form Howard Drive Elementary to Thalatta Estate and then again from 2:00pm to 3:00pm to return students from Thalatta Estate to Howard Drive Elementary School; and

**WHEREAS**, the in-kind services for use of two (2) Palmetto Bay Buses including drivers to shuttle students from Howard Drive Elementary School to Thalatta Estate lot shall not exceed \$150.00 including fuel; and

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:**

**Section 1.** The Village Council of the Village of Palmetto Bay hereby authorizes in-kind services for use of two (2) buses including drivers to shuttle students from Howard Drive Elementary School to Thalatta Estate, Friday, June 3, 2022, for an amount not to exceed \$150.00 inclusive of fuel.

**Section 2.** This Resolution shall take effect immediately upon adoption by the Village Council.
