**A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AUTHORIZING SHUTTLE BUS IN-KIND SERVICES FROM THE DEPARTMENT OF PUBLIC SERVICES FOR THE VETERANS' PARK TASK FORCE ON MAY 6, 2022, IN AN AMOUNT NOT TO EXCEED \$100.00 FOR THE ANNUAL POLICE MEMORIAL CEREMONY; AND PROVIDING FOR AN EFFECTIVE DATE. (Sponsored by Mayor Karyn Cunningham)**

**WHEREAS**, the Veterans' Park Task Force has requested in-kind services for the use of one (1) Palmetto Bay Bus from the Village of Palmetto Bay Department of Public Services, Division of Transit Operations for their May 6, 2022, Annual Police Memorial Ceremony at Tropical Park located at 7900 SW 40<sup>th</sup> Street, Miami, Florida; and

**WHEREAS**, the Veterans' Park Task Force is looking for the Village to cooperate with in-kind support in helping to provide transportation to and from the Marlin Moore American Legion Post #133 and Tropical Park via the I-buses; and

**WHEREAS**, due to the number of members attending the ceremony, the use of one (1) Palmetto Bay Bus with a driver to shuttle members from Marlin Moore American Legion Post #133 to Tropical Park is being requested;

**WHEREAS**, the in-kind service for use of one (1) Palmetto Bay Bus including driver to shuttle members from the Marlin Moore American Legion Post #133 to Tropical Park shall not exceed \$100.00 including fuel.

**NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:**

**Section 1.** The Village Council of the Village of Palmetto Bay hereby authorizes in-kind services for use of one (1) bus including a driver to shuttle members from the Marlin Moore American Legion Post
