**A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, REGARDING PERMIT FEES; WAIVING RESIDENTIAL BUILDING PERMIT FEES FOR THE INSTALLATION OF HURRICANE PROOF WINDOWS DURING THE PERIOD FROM JUNE 1<sup>ST</sup> THROUGH NOVEMBER 30<sup>TH</sup>, 2022; AND PROVIDING AN EFFECTIVE DATE. *(Sponsored by Mayor Karyn Cunningham)***

**WHEREAS**, current Hurricane modeling predicts that the South Florida are may experience up to nine hurricanes this season, three of which may result in major events, in addition to tropical storms that may affect the area; and

**WHEREAS**, in order to assist the Village residents in preparing for this Hurricane season, the Village will waive all building permit fees for the period of June 1 through November 30, 2022; and

**WHEREAS**, though the fees will be waived, all other building requirements, including applications and inspections will remain in place.

**NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:**

**Section 1.** That the above recitals are incorporated as if set forth in full.

**Section 2.** That Village building permit fees for the installation of Hurricane proof windows, doors and garage doors for residential 1 and 2, will be waived for the period of July 1, 2022, through November 30, 2022.

**Section 3.** That all other building code requirements will remain in place during this period.

**Section 4.** This Resolution shall take effect immediately upon approval.
