**AN ORDINANCE OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, REGARDING THE PARKS AND RECREATION AND COMMUNITY OUTREACH COMMITTEE; AMENDING ORDINANCE 2015-04 BY RESCINDING SECTION 2-55 (1)(b)(VI-XI) OF THE CODE OF ORDINANCES BY SUNSETTING THE COMMUNITY OUTREACH COMMITTEE AND ITS ADVISORY SCOPE; AMENDING SECTION 2-55 (1) OF THE CODE OF ORDINANCES BY RENAMING THE COMMITTEE THE "PARKS AND RECREATION COMMITTEE"; PROVIDING FOR CODIFICATION AND AN EFFECTIVE DATE. (*Sponsored by Mayor Karyn Cunningham*)**

**WHEREAS**, Ordinance 2015-04 established several advisory committees, including both a separate Parks and Recreation Committee and a separate Community Outreach Committee; and

**WHEREAS**, since the creation of the separate committees, the Code of Ordinances at Section 2-55 has combined the two forming the Parks and Recreation and Community Outreach Committee; and

**WHEREAS**, the Council wishes to sunset the Community Outreach Committee; and

**WHEREAS**, the name of the committee shall be changed to the Parks and Recreation Committee.

**NOW, THEREFORE, THE FOLLOWING ORDINANCE IS HEREBY ENACTED BY THE VILLAGE OF PALMETTO BAY, FLORIDA:**

**Section 1.** The above recitals are incorporated as if set forth in full.

**Section 2.** The Village Council hereby sunsets the Community Outreach Committee established by Ordinance 2015-04 and Section 2-55 (1)(b)(vi-xi) of the Village Code which established the advisory scope of the Committee.

**Section 3.** Section 2-55(1) of the Village Code shall be renamed the "Parks and Recreation Committee".

**Section 4.** The Village Clerk shall advise the codifier that the above Sections 2-55 (1) (b)(vi-xi) and 2-55(1) of the Code of Ordinances are to be shown as amended and in part repealed.

**Section 5.** This Ordinance shall become effective on Second Reading.
