RESOLUTION NO. 2016-126

A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, SUPPORTING THE DECEMBER 18, 2016, TOYS 4 KIDS EVENT AT WEST PERRINE PARK; PROVIDING FOR OFFICIAL SPONSORSHIP AND PARTICIPATION AND TRANSMITTAL TO INTERESTED PARTIES; AND PROVIDING FOR AN EFFECTIVE DATE. (Sponsored by Mayor Eugene Flinn)

WHEREAS, Palmetto Bay cares and has a history of supporting worthwhile causes that benefit our community, both in and nearby/adjacent to our municipal boundaries; and

WHEREAS, Cartel Baggers is presenting a “Toys 4 Kids” event at West Perrine Park, 10301 SW 170th Terrace, Miami, FL, 33157, on December 18, 2016; this event currently co-sponsored by Miami-Dade County Commissioner Dennis C. Moss, Miami-Dade County, Peterson Harley Davidson and many others (see attached event promotional flyer “*Exhibit A*”); and

WHEREAS, Palmetto Bay typically participates in Holiday charitable events, specifically including Toy Drives; and

WHEREAS, the Palmetto Bay Village Council approves the expenditure of up to \$2,000.00 to assist in the costs of this event; and

WHEREAS, this event, as presented through Linda Peterson, of Peterson Harley Davidson, is a meritorious event, deserving of participation of the residents of the Village of Palmetto Bay.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, AS FOLLOWS:

Section 1. The Village of Palmetto Bay supports both the concept as well as the participation in the Toys 4 Kids, scheduled for 1 PM on December 18, 2016, at West Perrine Park.

Section 2. The Village authorizes the Village Manager to take all action required to facilitate Palmetto Bay’s sponsorship and participation in this event, including, but not necessarily limited to the following action:

A. Provide police services worth \$2,000.00 for this event. These services are to allow for defraying costs associated with this event including but not limited to police service.

B. Provide for police assistance in assisting Golf Carts/Bikes – safe crossing from/to Palmetto Bay/Cutler Bay across US1.

C. Provide/allow the use of the Village Municipal Center as a designated drop off point for donated toys as coordinated with Linda Peterson, of Peterson Harley Davidson, who

1 has agreed to pick up and transport donated toys from the Village Municipal Center to the
2 distribution center.

4 D. Provide authorization for use of the official Village seal/logo for this event, listing
5 Palmetto Bay as an official sponsor.



11 co-sponsoring schools during business hours up until the day prior to the event.


