A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, APPROVING A DONATION TO THE AMERICAN LEGION POST 133 IN THE AMOUNT OF \$5,000 TO ASSIST WITH ROOF REPAIRS; PROVIDING AN EFFECTIVE DATE. (Sponsored by Councilmember David Singer)

WHEREAS, there has been discussion to use the facility for certain Village events and the building has been used in the past and will continue to be used for our Veterans' Park committee meetings, among other events; and,

WHEREAS, the Village wishes to donate \$5,000 to the American Legion Post 133 to assist with roof repairs needed to their building.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE OF PALMETTO BAY, FLORIDA, THAT:

Section 1. The Village Manager is authorized to make a total donation of \$5,000 to the American Legion Post 133 to assist with the cost associated with roof repairs to their building.

Section 2. This Resolution shall be effective upon adoption.



Re: Memo on donation to American
Legions roof repair

PURPOSE OF THE PROPOSED ACTION:

This proposed action will be to provide a donation to the American Legion for roof repairs.

MAJOR POINTS/REASONS FOR THE PROPOSED ACTION:

The American legion provides a valuable service to the community and does not have the funding available to cover a much-needed roof repair for its facilities. There is discussion of use of the facility for Village events and we currently use it for our Veterans' park committee meetings. Thru this memo I will be bringing forth a resolution donating the remaining charitable amount from the Council line item to help offset the costs of the roof repair and request that administration also enter into an agreement to rent the hall for senior activities.
