

**RESOLUTION NO. 2018-83**

**A RESOLUTION OF THE MAYOR AND VILLAGE COUNCIL OF THE VILLAGE OF PALMETTO BAY, FLORIDA, RELATING TO PROFESSIONAL SERVICES; APPROVING A TWO-YEAR EXTENSION OF THE CONTINUING SERVICES AGREEMENTS WITH THE CONSULTING FIRMS IDENTIFIED ON EXHIBIT A FROM THE LAST DATE OF EXPIRATION OF SAID AGREEMENTS; AND PROVIDING AN EFFECTIVE DATE. (Sponsored by Administration)**

**WHEREAS**, the Village had previously approved continuing services agreements with various professional consulting and engineering firms in the areas of architecture, civil engineering, electrical engineering, structural engineering, general planning, transportation planning, landscape architecture, and plumbing and mechanical engineering so that the Village may implement studies, repairs or improvements expeditiously and effectively; and,

**WHEREAS**, the selection process for the various trades is a lengthy one and the Village desires to extend the continuing service agreements with the previously-qualified firms, identified on Exhibit A, for a period of two years from the last expiration date of the agreements so that the Village may proceed with any existing projects while a new procurement process is underway.

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE OF PALMETTO BAY, FLORIDA, THAT:**

**Section 1.** The continuing service agreements for the previously-qualified firms as identified on the attached Exhibit A are hereby extended for a period of two-years from the date of expiration of each agreement.

**Section 2.** This Resolution shall be effective upon adoption.
